1:00 PM *Final Update on High Line Canal Acquisition

The purpose of this study session was staff presented a final update to the Board of County Commissioners (BOCC) on the latest negotiations and items completed for closing.

Staff presented an update on the closing documents for the High Line Canal acquisition. All but one document has been finalized. The final documents have been split into three deeds and three assignments based on counties.

Commissioner Holen arrived at 1:06 PM.

Staff discussed that after the signature is the transitionary period.

The procedure for project applications was presented. The approval process would need to work with Arapahoe County, Denver Water, the High Line Canal Conservancy, and other local government agencies. The goal is to have concurrent review for efficiency.

The partners involved with the acquisition are scheduling a celebratory meeting.

BOCC recognized staff from Open Spaces for their work during this acquisition.

Commissioner asked about staffing for the High Line Canal. Staff discussed the next steps after the acquisition during the transitionary period and available resources.
