Let us know if you have any questions and if you want us to meet you on your first load just give us advance notice. We can give a tutorial. There are instructions on the permit, and the fill station is user friendly so you shouldn't have any issues.

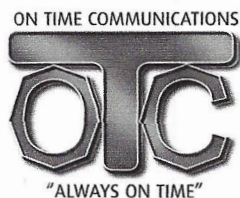

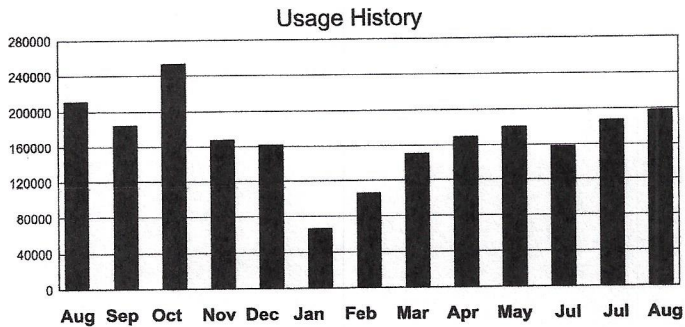
