 - a. Developed Outreach Team
 - b. Started in 10/23 now 820 Outreached and 328 successfully connected to services
 - i. Built relationships with local organizations
 - ii. Do lots of warm hands off to partners
 - iii. Engaging more volunteers
 - c. Goal: 1500 outreached, 600 successfully connected

 - a. AGO Opioid Settlement Conference
 - i. Loveland, Sept 30, sign up here (8:30-4:30)
 - ii. Steadman Group will be there
 - b. Naloxone Bulk Fund Prioritization Plan
 - i. Coming to an end. Money is running out.
 - 1. CDPHE is making a plan to get the high priority organizations the remaining Naloxone
 - a. Reduction in scope of eligible organizations
 - 2. Will need to have standing orders
 - a. Capped at 4 mg Naloxone
 - ii. Need to start thinking of alternative sources for Naloxone
 - 1. Will help connect with organizations that have Naloxone

- 2. Still available OTC and through Medicaid and commercial insurance at pharmacies.
 - a. Still free to the user
 - Way for individuals (not organizations) to gain access to Naloxone
- 3. Potential to use opioid abatement funds to address gap

- 5. Strategic Planning (60 mins)
 - a. R9 funding calendar review (10)
 - i. Will develop a form to the opioid settlement website and accept program ideas/requests year-round in addition to formal RFP process.
 - 1. Form will ask:
 - a. What is needed?
 - b. How much money is needed?
 - 2. Will be reviewed by council
 - 3. Would be added to funding request deadlines in march and sept
 - 4. Will be embedded on Arapahoe County website
 - 5. Filled out forms will be accessible in shared Google Drive and held by County (for record keeping purposes)
 - ii. Quarterly data updates and program spotlights
 - 1. Purpose to inform funding decisions
 - 2. We will be looking at data cumulatively to see progress over time
 - a. End of year
 - 3. At quarterly data updates is more of a data check
 - iii. RFPs in the fall each year (August)
 - iv. Every other year in the fall, council will decide whether to continue funding for programs (since they are funded for 2 years)
 - v. First year this calendar is implemented is 2025
 - b. Workgroups
 - i. Workgroup work time (40)
 - ii. Workgroup share out (10)
 - 1. Workforce Development
 - a. Ready to allocate 50% of funds toward new credentials, 50% toward "continuing education".
 - b. Part will go to schools and part will go to employers.
 - i. They will finalize in August.
 - ii. JK to help Steve with notes on the different schools.
