Thank you for the opportunity to comment. Arapahoe County Open Spaces and State Land Board are currently in negotiations and have executed a Letter of Intent regarding the potential future acquisition of part of the Lowry lands. For future OS acquisition and public access for recreation, a pipe line easement like the one here for the Secret Stash well could cause an issue for crossing it with a trail or access road, unless easement language allows.

We agree with the preferred alternative shown on Appendix L: Alternatives Map, the Red route would be least impactful to wildlife, habitat and any future County ownership. Creation of public access like: trails or access roads would be less likely to cross the preferred alternative. Preferred alternative also follows an existing roadway that already caused habitat impact. The north Blue line alternative seems to cross more undisturbed habitat and would be more impactful to the land and wildlife.




