##### A. 3L SPA Internship Program

- Description
  - 3L SPA interns at the 18th Judicial District Attorney's Office handle traffic and misdemeanor cases under the supervision of licensed attorneys. Interns participate in help handle dockets, argue motions, and engage in all aspects of trial work. They also research and respond to defense motions, prepare motions for the People, and work closely with victims, witnesses, and defense counsel. They are crucial to staffing Division 101, as well. This internship provides extensive courtroom experience and training, preparing interns for a future career as prosecutors.

##### B. 2L Appeals Internship Program

  - An Appeals intern focuses on appellate-level legal work, including conducting detailed research, drafting briefs, and reviewing trial records to identify legal issues. They assist in preparing motions, post-conviction relief filings, and oral argument outlines. Appeals interns work closely with supervising attorneys to ensure high-quality appellate submissions and support the broader goals of the Appeals Division.
