**RESOLUTION NO. 1012-96** It was moved by Commissioner Nicholl and duly seconded by Commissioner Eggert to adopt the following Resolution:

WHEREAS, the Colorado General Assembly made effective on July 14, 1975, through Section 29-7-101, Colorado Revised Statutes, 1973, as amended, provisions for the regulation and control of public recreation lands and facilities owned or operated by the County; and

WHEREAS, the Board of County Commissioners has been delegated the power, authority and jurisdiction to adopt such rules and regulations as are reasonable necessary for the administration, protection and maintenance of Arapahoe County owned or operated public recreational lands or facilities; and

WHEREAS, pursuant to Section 29-7-101(b), Colorado Revised Statutes, 1973, as amended, any person violating any such rule or regulation is guilty of a class 3 misdemeanor and, upon conviction thereof, shall be punished as provided in Section 10-1-106, C.R.S. 1973;

WHEREAS, pursuant to Section 29-7-101(b), Colorado Revised Statutes, 1973, as amended, it is the duty of the Sheriff and his Undersheriff and deputies, in Arapahoe County, to enforce the rules and regulations so adopted, and the County Courts of Arapahoe County have jurisdiction in prosecution of any such violation; and

WHEREAS, it is the desire of the Board to adopt rules and regulations concerning the unlawful conduct on Arapahoe County owned or operated public recreational lands or facilities pursuant to the above-referenced statute as follows:

- It shall be unlawful to remove, destroy, mutilate or deface any structure, poster, notice, sign or marker, tree, shrub or other plant or vegetation or rock or any object of archeological, geological or historical value or interest.
- 2. It shall be unlawful to trap, catch, molest, harm, or chase any wildlife, wildfowl, or fish, or to molest their natural habitat, except as elsewhere provided in the Rules and Regulations.
- 3. It shall be unlawful to hunt and/or fish except in those designated areas allowing such activity and only in accordance with current State and Federal regulations.
- 4. It shall be unlawful to operate any motorized vehicle within Arapahoe County Open Space Parks or Recreational Facilities, except on designated lakes, roads, trails and parking lots. Unless otherwise posted, authorized vehicles shall not be operated in excess of 25 miles per hour.
- 5. It shall be unlawful to park vehicles or trailers in areas other than those designated and posted as parking areas.
- 6. It shall be unlawful to camp, park a trailer or camper for camping purposes in areas that are not specifically designated for camping.
- 7. It shall be unlawful to leave refuse or rubbish, including but not limited to, tin cans, bottles, plastic or paper cartons, human excrement, fish entrails or other litter, or to deposit same in streams or lakes. Toilets, garbage pits and other refuse receptacles must be used for disposal of such materials.
- 8. It shall be unlawful to build, start, or light a campfire, bonfire, or fire of any nature except in designated areas in outdoor grills.

- 9. It shall be unlawful to discharge firearms or explosives of any kind, or BB guns, pellet guns, air guns, cross bows, long bows and sling shots except by law enforcement officers on official duty or in areas designated for such use.
- 10. It shall be unlawful to discharge or use fireworks of any kind or nature in any Arapahoe County Park.
- 11. No grazing of livestock shall be authorized except as approved by the Board of County Commissioners in writing.
- 12. It shall be unlawful to picnic in any areas not designated for picnicking purposes.
- 13. It shall be unlawful to park in any area except where properly designated for parking, and then, only in compliance with the notices, as posted.
- 14. It shall be unlawful for any person to violate any curfew provision which is properly posted on any recreational land or facility or open space property or park.
- 15. It shall be unlawful for any person to engage in any activity in a public park which may constitute a hazard to the safety of said person and other users of such facility, except that such activity may be conducted in an area specifically designated for such activity. Such activities, as examples, may include, but are not limited to: archery, hitting of golf balls and horseback riding.

WHEREAS, for the above-stated and numerous other reasons, the above enumerated rules and regulations are in the best interest of the health, safety, welfare and morals of the citizens of Arapahoe County, State of Colorado.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Arapahoe County that:

- 1. The above enumerated rules and regulations are necessary for the control of unlawful conduct of persons on County-owned or operated public recreation lands and facilities.
- 2. The above-reference rules and regulations be and hereby are approved and adopted.

BE IT FURTHER RESOLVED that these rules and regulations shall specifically apply to those public recreational lands or facilities as described as follows, and

incorporated herein by reference, and to any public recreational lands or facilities hereafter acquired by Arapahoe County.

Arapahoe County Community Park - located at 7800 South Chambers Road.

Tsistsistas - Hinono'ei (Cheyenne/Arapaho) Park - located at 9300 E. Iowa Avenue.
