History:

On October 24, 2023, Facilities and Fleet Management (FFM) presented the Countywide Facilities Master Plan to the Arapahoe County Board of County Commissioners (BoCC). During that presentation, the following topics were presented and discussed:

- Countywide Facilities Master Plan
- Notable Expiring Leases
- Initial Project Recommendations

Requests from 2023:

- Approval for FFM's use of the Facilities Master Plan as a framework for long- range County planning
- Endorsement of FFM continuing to act as facilitator/planning agent for development of future space modification plans/ budget requests as brought forward by stakeholders for consideration through existing budget processes

Both requests approved by BoCC with 5-o vote on October 24, 2023



Purpose of the Space Study (2023)

Identify Opportunities to:

- Consolidate leased space into owned space where feasible
- Consolidate occupancy within facilities where feasible when space is underutilized
- Best leverage County assets to serve residents into the future
- Centralizing services to optimize County's position to serve its residents

Provide the tools to:

- Assess and program space needs when presented
- Track space-availability based on completed projects and/or shifts in operating paradigm and remote work practices




Factors to Consider:

- Available Funding




Initial Project Recommendations - Where Are We Now?

Completed Space Utilization Projects/Proposals:

- •911 Backup Call-Center at Admin Complete Q1 2024
- •Human Services Family Time Rooms (10 new rooms at CentrePoint) Complete Q4 2024
- •DA Diversion at APZ South Complete Q4 2024
- •AD Works Space Consolidation at Lima Plaza Substantially complete Q4 2024 (closeout in progress)

Space Utilization Projects/Proposals on the Horizon:

- •Clerk & Recorder Call Center at Admin Phase 2 will be submitted for 2026 CIP consideration
- •Aurora DMV Currently researching options for relocation with C&R
- •DA Revere Space Needs Design fee proposal received
- •ACSO Training Space Needs (Central) Currently researching options with ACSO
- Altura Plaza
- Open Spaces Maintenance Shop Space Needs (Central and East)
- Byers Vacant Property Development (ACSO, DMV, other?)
- Create a County-Wide Vacancy Plan (open desk plan)



Space Utilization Process Request

- Space utilization requests from all departments and elected offices should be submitted to FFM via the Space Request Form. (form link on FFM intranet page)
- FFM will evaluate the requests and per the approved criteria presented to the BoCC on October 24, 2023.
- FFM will act as facilitator/planning agent for development of requested space modification plans and will assist the department or office with conceptual planning and development of budget requests for future projects.

General guidelines:

- FFM will initiate discussions regarding underutilized space only to meet a need presented through this process or an emerging operational requirement.
- Departments and elected offices will utilize this process and will not initiate space discussions
 or occupy spaces not previously allocated to them on their own.
- Capital projects will be developed through approved Finance protocols for budgetary approval.

Current Request:

Approval of FFM's space utilization request process to be used county-wide for space requests.
