



### What is a Health Assessment? Public Health Act of 2008

- 5-year assessment and planning cycle at state and local levels
- Goal: Increase availability and quality of public health services and improve health outcomes
- Result: A strategic plan for the entire community whereby local public health system partners collectively address priority areas
- Public Health Director Role: Direct the completion of a community health assessment
- Local Board of Health Role: Approve the local public health plan
- Board of County Commissioner Role: Share insight on community strengths, needs, and priorities; consider policy solutions to improve health



### Benefits of a Health Assessment

- Assess and monitor Population Health
- Use data to determine the root causes of health disparities and inequities
- Collaborate and facilitate **data sharing** with partners
- Use innovative technologies, data collection methods, and data sets
- Interpret and communicate data to diverse audiences
- Analyze and disaggregate data (e.g., by race) to track issues and inform equitable action
- Engage community members as experts and key partners

Geographical data helped to identify communities that might require tailored support



## Methodology



CHA data were compiled from a variety of sources and include:

- Primary Data
- Secondary Data
- Quantitative Data
- Qualitative Data

To capture a broad range of voices we:

- Identified current health concerns and reached out to those most affected.
- Sought input from historically underrepresented and oppressed communities.
- Engaged regions in the county with the highest vulnerability using the CDC Social Vulnerability Index





## 7 in 10

of those in Arapahoe County with an annual income of \$75,000 or more report excellent or very good health, in 2022. One in five people in Arapahoe County making less than \$25,000 a year reported poor mental health

Self-Reported General Health Status by Household Income, Arapahoe County, 2022








#### Employment Status for the Population 16 years and over, 2022 5-year


- The general unemployment rate has decreased in 2022. yet, it was highest for African Americans/Black Arapahoe County community members.


The increase in rent (28%) is outpacing the increase in wages (22%)


In June 2023, the national median sale price for the typical starter home was \$243,000 — up more than 45% from before the pandemic.

#### Self-reported conditions and barriers to housing

**27%** Physically Disabling Condition **30%** Mental Health Concern **22%** Chronic Health Condition **31%** Substance Use

Since 2015, most people (88%) who shared previous address information in HMIS report a last permanent address in Colorado, disrupting the misconception that people are moving from out of state and becoming homeless

- > Homelessness is a multifaceted issue, and its complexity arises from a web of factors, including economic instability, lack of affordable housing, and in some cases, issues like mental health and substance use.
- > In Arapahoe County, there was nearly two times the number of people experiencing homelessness in 2023 (442) compared to 2020 (245), with 52% of those experiencing unsheltered homelessness. 19





### School Safety and Health

In Arapahoe County, LGBTQIA+ students more often reported missing school due to feelings of unsafety.

High School Students Who Reported Missing School Due to Feelings of Unsafety by Sex and Sexual Orientation, 2021






1 in 6

students reported having been absent one or more days in the past month due to feeling unsafe (17%).

The majority of deaths due to domestic violence in 2022 were caused by firearms

- In 2021, Colorado had an all-time high number of domestic violence fatalities (DVFs) since 2017. The number for 2022 was higher there were 94 DVF in 62 cases.
- Of the 94 people who died due to domestic violence, 86% of were caused by firearms.
- In 2021, approximately 8% of high school-aged students in Arapahoe County reported being physically hurt by someone they were dating.

### **Firearms and Health**

In 2022, 37% of Colorado and 29% of Arapahoe County residents reported keeping a gun at home

## 59%

of suicide deaths occurred with a firearm in Arapahoe County, in 2022.

## 37

youths between the of 1-17 died in Arapahoe County due to firearm-related homicide, between 2000 and 2022.



- In Colorado, firearms are the leading cause of death associated with suicide, community violence, domestic violence, and targeted mass shootings.
- Prevention, education, treatment, and rehabilitation stand as pillars that enhance public safety.



#### Youth Firearm Homicide Deaths, Youth Ages 1-17 Years, Arapahoe County, 2000-2022 (n = 37)




Access to Physical and Behavioral Care



### **Coverage and Health**

Failure to complete the renewal process is the most common reason for procedure denials




- The PHE (Public Health Emergency) Unwinding disenrollment percentage of 44% is within 3% point of the 41% pre-pandemic rate.
- The bars on top show the average PHE Unwind procedural denial rate (25%), after the 90-day reconsideration period. This is about double historic norms.
- The middle bars illustrate current denials due to income and other criteria.



### **Cost and Health**

### In 2023, nearly 1 in 3 people in Arapahoe County reported receiving a surprise medical bill

of Arapahoe residents reported not receiving specialty care due to cost concerns in 2023, an increase from 12% in 2021.

72%

of Arapahoe County adults had dental insurance in 2022, and 67% had a dental visit in the past year.




### **Access and Health**

Reported transportation barriers to care did not improve or worsen in 2023 compared to 2021

## 15%

of people needed mental health services but did not receive them, and 62% of people cited unavailability as the reason, in 2023.

 In 2023, more people in Arapahoe County reported not being able to access an appointment with a doctor's office/clinic on time than in 2021.



Reported barriers to Access by Year, Arapahoe County, 2021 and 2023




### Immunizations and Health

Decreasing vaccination rates may increase the risks of the reemergence of preventable diseases

## 86.8%

of kindergartners were vaccinated against measles, mumps, and rubella (MMR) in 2022.

 In the 2022–23 school year, nearly half of school districts reported over 90% of kindergarteners protected with all DTaP, HepB, MMR, Polio, and Varicella vaccines; other districts reported 90% or higher vaccination outcomes in some vaccines but not all. # **Environment and Heat and Water**

Youth, older adults, people experiencing homelessness, the outdoor workforce, and other vulnerable populations are at the highest risk for extreme heat days.

**2**,**3** degrees, with most warming in fall, is the

average warming temperature in Arapahoe County.  According to the Heat Vulnerability Index, Arapahoe County census tracts had a mean score of 16.2 compared to 17.5 nationally, with a higher number indicating greater vulnerability.


 The most vulnerable tracts are in northwest Aurora, by Hampden Avenue and South Broadway.

 More than 75% of Arapahoe County residents are served by Aurora Water and Denver Water, which rely on the Colorado River for approximately 25% and 50%, respectively, for their water supply.






#### Arapahoe County Heat Vulnerability by Census Tract



### **Environment** and Air Quality

Percentage of Days with Good Air Quality, Arapahoe County, 2000-2022



Air quality in Colorado has been steadily decreasig over the past few decades.

 Poor air quality contributes to many adverse health outcomes, including respiratory disease, cardiovascular disease, and cancer.

 In 2020, the EPA designated the Denver Metro Area/
Front Rage as a "serious" nonattainment area for ozone. The area was reclassified as "severe" in 2022.

### **Environment** and Open Spaces

Community members expressed the desire for environmental programs to promote environmentally conscious practices.

~13,000


acres of open space have been added to Arapahoe County since 2014.  Open spaces, including both undeveloped natural areas and human-constructed environments (parks, greenways, etc.), are vital to good health and wellbeing.

- Depression and anxiety are 33% and 44% higher, respectively, in areas with the least amount of green space, compared to those who live in the greenest areas.
- Residents in our municipalities have varying accessibility to green spaces.

## Food and Health

## 11%

price increase on food occurred nationally in 2022, a steep increase compared to previous years (a 3.5% increase in 2020 and 2021).

16%

high school aged youths reported facing hunger exceeding the state of Colorado's rate of 12.4% in 2021. Food-insecure older adults are 53% more likely to report a heart attack and 52% more likely to develop asthma.

- Surges in food prices disproportionately affected the households with the lowest incomes. In 2022, American households in the lowest income range spent over 30% of their household income on food, while the highest-income households spent only 8%.
- Households with children, particularly those led by single mothers, face a higher likelihood of food insecurity—more than three times that observed in households with married couples and children.

increase in the number of Arapahoe County families that applied and received SNAP benefits was seen from 2019-2022.

\$7.4 M

from WIC purchases in Arapahoe County grocery stores occurred in 2022.

Food insecurity persists in Arapahoe County, disproportionately impacting low-income and marginalized communities

 Supplemental Nutrition Assistance Program (SNAP) and WIC are vital federal aid programs for nutritious food, but not all people who need assistance qualify. Other factors, such as immigration status or certain income criteria, may exclude individuals, underscoring the necessity for a comprehensive approach to address food insecurity in communities.

 SNAP assistance issued in 2022 in Arapahoe County totaled \$14.4 million.

 In 2023, the number of Arapahoe County WIC participants exceeded the 2019 average, reversing the 2022 downward trend.
