Notices of all other Arapahoe County committee and board meetings, and notices of meetings of the BOCC, Board of Retirement, Cultural Council, Regional Opioid Abatement Council, Arapahoe County Foundation, Inc., Arapahoe County Liquor Authority, and the Justice Coordinating Committee in the event such notices are unable to be posted online, shall be posted at the Arapahoe County Administration Building at 5334 West Prince Street, Littleton, Colorado, in the glass case next to the West Hearing Room; except that notices of the Board of Health, Arapahoe County Planning Commission, OSTAB, the Arapahoe County Zoning Board of Adjustment, and the Arapahoe Transportation Forum in the event such notices are unable to be posted online shall be posted at the Arapahoe County Public Works and Development Lima Plaza Building at 6924 South Lima Street, Centennial, Colorado, in the glass case in the main entrance.
