APPEARANCE RELEASE

This release ("Release") is made to allow Michelle Khare Inc. and/or its affiliates, subsidiaries, successors, licensees, assigns and designees (collectively, "Producer"), to include me, the undersigned, as a participant ("Participant") in a production and/or publication (collectively, "Production"). I am giving this Release in consideration of Producer allowing me to participate as a Participant and I recognize that my signature on this Release is a condition of Producer permitting me to be a Participant in the Production. I agree that Producer may tape and photograph me and record my voice, conversation, persona, and performances, including, without limitation, quotes, paraphrases, sounds, and musical composition(s), for use in connection with the Production (my "Participation"). I acknowledge and agree that the Production may contain information, statements, or representations ("Information") relating to me of a personal, private, disparaging, embarrassing, and/or unfavorable nature, and that such Information may be summarized, edited, or modified in a manner that may be untrue or misleading and may expose me, my family, and others to public ridicule or embarrassment. Nonetheless, I voluntarily agree to participate in the Production with full knowledge of the foregoing and freely and voluntarily assume all risk associated therewith.

I agree that Producer shall be the exclusive owner of all copyright and other rights in and to the Production, my Participation, and any excerpts and results and proceeds therefrom (collectively, "Proceeds"), all of the same being deemed a work made for hire and commissioned by Producer, and if it is determined the Proceeds do not qualify as a work made for hire, then the Proceeds are assigned by me to Producer pursuant to this Release without further formality. Without limiting the foregoing, Producer will have the exclusive, irrevocable, worldwide, right in perpetuity to use, and license or otherwise authorize others to use the Proceeds, as well as my name, voice, likeness and any biographical facts which I have provided to Producer, in any and all manners and media now known or hereafter discovered or developed that Producer wishes. Except as provided for and set forth in the Location Release Form executed in connection with this Production, which is adopted and incorporated herein by reference, I hereby waive any right of inspection or approval of the Production or the uses to which the foregoing materials may be put, and no one is obligated to include me in the Production or any other materials. I hereby waive the benefit of any provision of law known as "droit moral" or moral rights of authors or any similar or analogous law or decision in any country of the world.

I understand and agree that this Production is a non-guild production and there will be no residual or any other type of payment due in connection with my Participation.

I hereby agree not to sue and irrevocably and unconditionally release, waive, and forever discharge Producer, and its past, present and future parents, subsidiaries, affiliates, divisions, agents, officers, directors, representatives, employees, licensees, successors and assigns, jointly and individually (collectively "Releasees"), from any and all manner of liabilities, claims and demands of any kind or nature, whatsoever, in law or equity, whether known or unknown, which I and/or my heirs, next of kin, spouse, guardians, legal representatives, employees, executors, administrators, agents, successors and assigns (collectively, the "Releasing Parties") ever had, now has, or in the future may have against the Releasees, including, but not limited to claims arising out of or related to the uses described herein, the Production, and my Participation. As such, I hereby agree and acknowledge on behalf of myself, and the Releasing Parties that there is a possibility that subsequent to the execution of this Release, I or they will discover facts or incur or suffer claims which were unknown or unsuspected at the time this Release was executed, and which if known by me or them at that time may have materially affected my decision to execute this Release. I and the other Releasing Parties acknowledge and agree that by reason of this Release, I and the other Releasing Parties are assuming any risk of such unknown facts and such unknown and unsuspected claims. I and the other Releasing Parties have been advised of the existence of Section 1542 of the California Civil Code, which provides:

"A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY."

Notwithstanding such provisions, this Release shall constitute a full release in accordance with its terms. I and the other Releasing Parties knowingly and voluntarily waive the provisions of Section 1542, as well as any other statute, law, or rule of similar effect, and acknowledge and agree that this waiver is an essential and material term of this Release, and without such waiver I would not have been permitted to participate in the Production. I and the other Releasing Parties hereby represent that I and they have been advised by their legal counsel, and acknowledge and understand the significance and consequence of this Release and of this specific waiver of Section 1542 and other such laws. I acknowledge and agree this Release is intended to operate and be construed as broadly as possible under applicable law.

Producer agrees to use reasonable care to prevent injury or loss to Participant and shall indemnify Participant for any legal liability arising out of bodily injury or property damage (ordinary wear and tear excepted) as a direct result of Producer's negligence. Producer, including its designees, employees, agents and contractors hereby release, waive and covenant not sue Arapahoe County or the Board of County Commissioners of the County of Arapahoe, including but not limited to the Arapahoe County Sheriff's Office (collectively the "Arapahoe Parties"), and their elected and appointed officials, directors, members, employees, affiliates, agents, contractors, successors and assigns from and against any and all liability, claim, demand, cause of action, damage, loss or expense, including court costs and reasonable attorney fees, or any kind or nature which may arise out of, result from, or relate in any way to the Production and/or any activities arising out of or relating to this agreement unless caused by the Arapahoe Parties' negligence or willful misconduct.

I represent and warrant that I am 18 years of age, that I have the full right to enter into this Release and/or that Participant is authorized to enter into this Release on behalf of any employees of the Arapahoe Sheriff's office or other third parties under Participant's control who will appear in the Production. I further represent that all information and contributions I am providing to Producer under this Release are valid, true, accurate, and/or do not violate the rights of any third party (including third party copyrights and rights of publicity), and that I have (or will concurrently provide) to Producer full and accurate information regarding my name (including prior names, aliases and professional/stage names), address and date of birth, for Producer's record-keeping purposes. This Release sets forth the entire agreement between me and Producer with respect to the subject matter hereof, may not be altered or amended except in writing signed by both parties, and will be binding on all of my successors-in-interest and heirs. Producer may transfer and assign this Release or all or any of its rights or privileges hereunder to any entity or individual without restriction and I may not assign this Release. In no event shall I have the right to enjoin the development, production or distribution or exploitation of the Production. Each provision of this Release is severable and the invalidation of one provision will not affect the validity of those which remain; the remaining provisions being deemed to operate and to be effective to the maximum extent permitted by law. This Release shall be exclusively governed by the laws of the State of Colorado and any dispute arising out of this Release shall be exclusively heard and resolved before the courts located in Arapahoe County, Colorado.
