

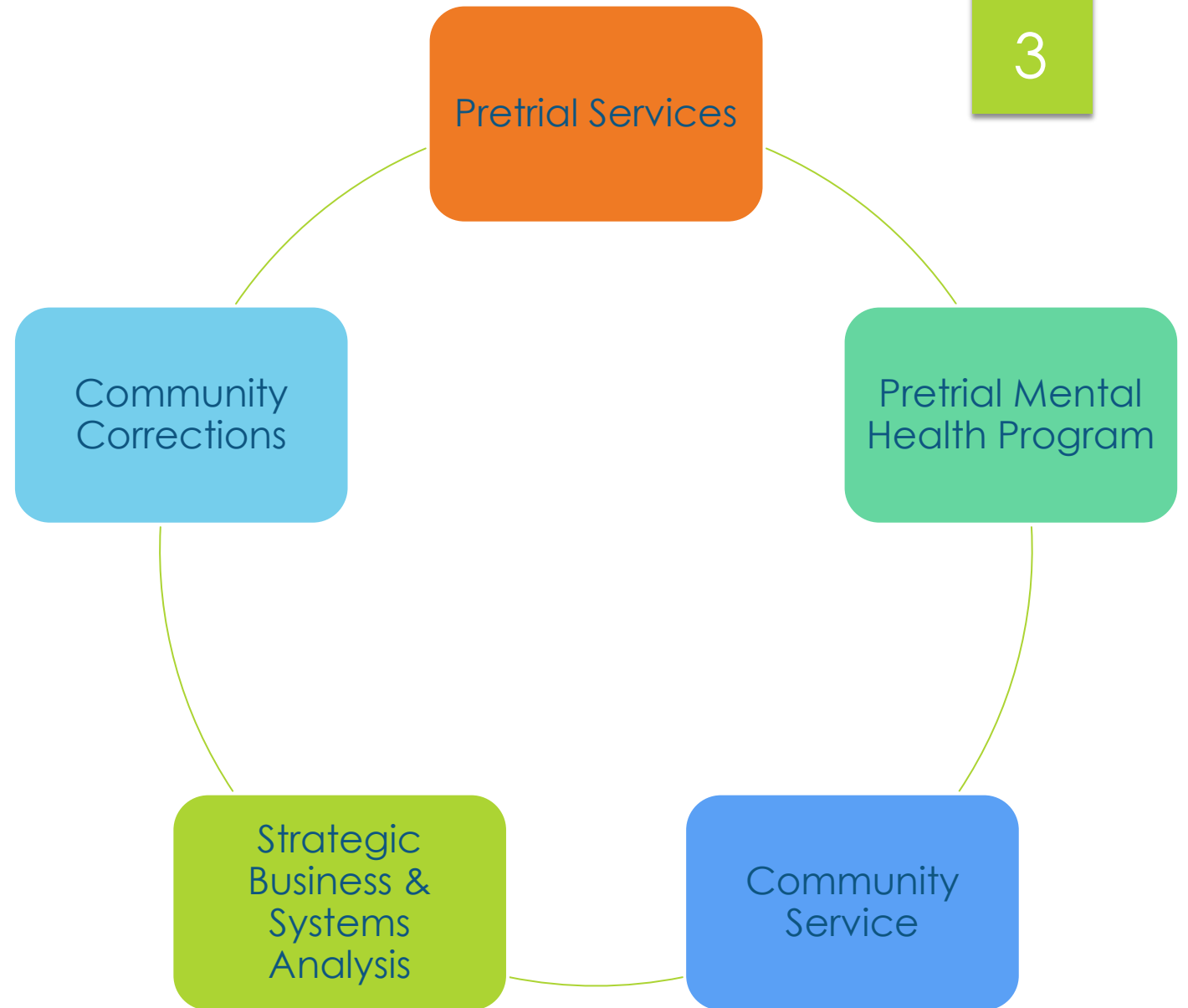


ARAPAHOE COUNTY Judicial Services Overview

PRETRIAL SERVICES: CASE MANAGEMENT

- Average daily caseload in 2023: 820
- In 2023, the average daily population of the Arapahoe County Detention Facility was 897.

► Increased Public Safety

- 96% Public Safety Rate
- For those who successfully complete Pretrial Services, they are 37% more likely to successfully complete Probation.

► Increased Economic Productivity

- Defendants can maintain employment.
- \$5 per day to supervise individuals v. \$135 per day to house individuals in jail

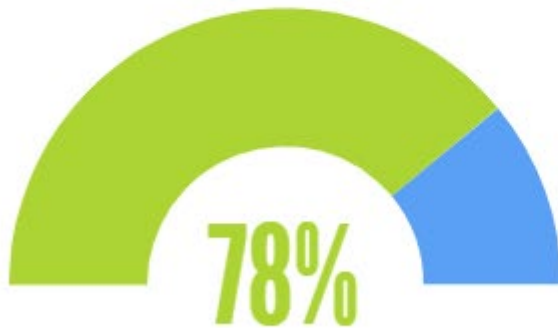
► Improved Community Wellbeing

- Defendants are able to maintain familial and prosocial peer relationships while being supervised by Pretrial Services

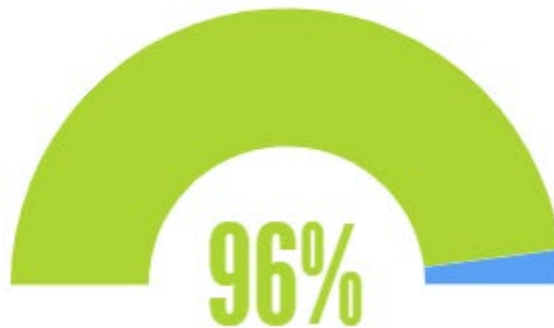


SB 19-191 requires the installment of GPS devices on defendants within 24 hours of posting bond, requiring intakes 365 days a year.

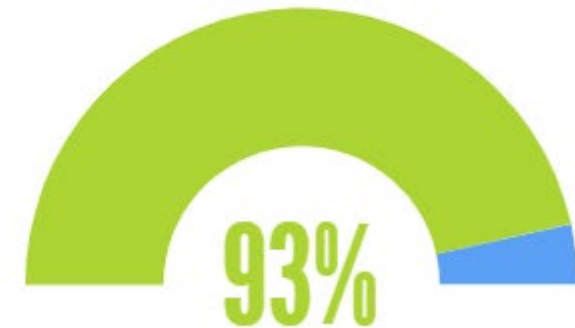
2023 Pretrial Supervision Outcomes

\$3,273,750 saved due to jail bed days avoided

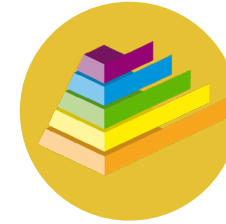


number of supervised PR bonds ($n = 970$) x annual average LOS (25 days) x average cost of jail bed (\$135/day)

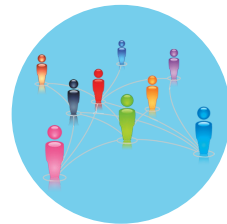
PRETRIAL MENTAL HEALTH PROGRAM



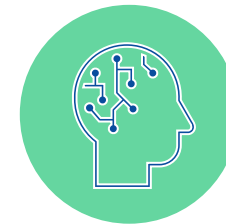
Specialized supervision for defendants with mental health diagnoses or dually-diagnosed

PRETRIAL MENTAL HEALTH PROGRAM IMPACTS

Reduced Crime

PMHP clients who terminate the program successfully recidivate at a rate 19% lower when compared to a similar population.

Improved Community Wellbeing

Annually, the PMHP makes almost 6,000 connections for clients to services related to treatment, medical appointments, community and social services, housing, and family connections.

Since 2021, there has been a 21% decrease in court-ordered community service intakes.

COMMUNITY SERVICE IMPACTS

Increased Public Safety

Individuals ordered community service by the Court are 60% more likely to successfully complete their Probation sentence.

Improved Community Wellbeing

Connects clients with organizations, providing exposure to prosocial activities clients may not otherwise have had.

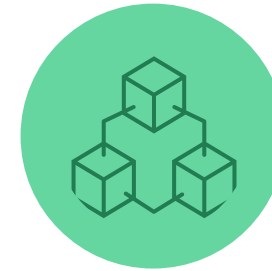

In 2023, the General Fund Programs cost **\$2,451,359** to operate, and they saved **\$5,732,519** through the avoidance of jail days due to pretrial supervision and a reduction in failures to appear and probation violations.

Community Corrections

 - ▶ Arapahoe Community Treatment Center (ACTC)
 - ▶ Centennial Community Treatment Center (CCTC)
- ▶ One co-ed facility – GEO Group
 - ▶ Arapahoe County Residential Center (ACRC)

BENEFITS OF COMMUNITY CORRECTIONS



- ▶ Increased Economic Productivity
 - ▶ Community Corrections routinely connects clients with jobs and vocational training to improve their economic potential.
- ▶ Reduced Recidivism
 - ▶ Programming is tailored to reduce clients' risk of reoffending.
 - ▶ In 2021-2022, clients reduced their average LSI score, after six months of residency, by 7 points – effectively moving the average client from high to medium risk.
