



# Background – Statewide

- Established joint framework to share future opioid settlements with local regions around the state.
  - •95% of impacted local governments have signed onto the Colorado MOU.
- Under the Colorado MOU, all settlement funds must be used only for "Approved Purposes," a long and broad list that focuses on abatement strategies. These strategies emphasize prevention, treatment and harm reduction.
- State Abatement Council will oversee implementation of MOU, including grant program for state infrastructure share.

# Background – Arapahoe County

- Arapahoe County will serve as convener and fiscal agent for Region 9.
- 12 out of 13 municipalities have signed onto the Arapahoe County (Region 9) IGA – Deer Trail did not sign the state MOU and is not eligible to receive funds.
- The IGA outlines the composition and membership of the Arapahoe County Regional Council.



# Background – Regional Council

- Must be established within 180 days of effective date (September 2022)
- Can establish intra-regional agreements on how the Council will operate
- Voting members must be an employee or elected official of a participating local government
- Need to certify establishment of Regional Council to State Abatement Council
- Build a two-year plan identifying approved purposes for funds
- Annual reporting to State Abatement Council on expenditure data
- •Open meetings compliance (including posting and agendas)

### Process | Timeline

#### August - October

#### Complete 2-year abatement plan

- 1. Set the stage Roles, expectations, logistics
- 2. Define the 5 allowable spend categories: Prevention, Treatment, Recovery, Criminal Justice, Harm Reduction
- 3. Review existing resources/strengths, gaps, local data, ROIs, evidence-based strategies
- 4. Generate and prioritize spend strategies
- 5. Allocate funds to prioritized strategies
- 6. Abatement plan details Goals, outcomes, equity

#### Nov - Jan: Implementation, Sustainability

• RFP process (development, selection, evaluation)



### TSG ROLES AND RESPONSIBILITIES

#### Facilitate

- Up to 18 governance committee meetings between now and July 2023.
  - Meet more frequently up front to complete 2-year plan

#### Distribute

Meeting minutes, recordings, and other necessary follow up materials to Committee Members

#### Assist

- Committee development, including technical advisory committee
- Submit state required deliverables (2-year plan)
- Develop succession plan to aid committee in sustainability



### **GOVERNANCE COMMITTEE RESPONSIBILITIES**

To determine broadly the allocation of regional settlement funds to prevention, treatment, recovery, criminal justice and harm reduction activities

Ensure your county/org is participating in items related to the settlement, but outside the scope of meetings

- IGA
- Opt in/out process

Attend and participate in Committee meetings

Meetings will become less frequent after 2-year plan is formed

Help develop RFP's for executing prioritized solutions

Bring your expertise and experience on to the discussion to inform the 2-year plan

Help evaluate proposals and select organizations to implement prioritized solutions

### Governance Committee Elected Positions

CHAIR: At the first meeting of each year, the Voting Members shall appoint one Voting Member to serve as Chair of the AC Regional Council.

- The Chair's primary responsibilities:
  - Schedule periodic meetings and votes of the Regional Council, as needed
  - Serve as point of contact for facilitators (TSG) and disputes within the Region.
- The Chair must be either a Voting Member from Arapahoe County or a city or town w/i region
  - IE: county commissioner, mayor, town councilmember
- Voting Members may also appoint other officers
  - <u>Vice-chair</u>
  - Recording secretary





## Technical Advisory Committee: TSG Lessons Learned

Center voices with lived experience!

Include SUD subject matter experts and population experts

- •SUD/OUD treatment providers
- •Recovery community organizations
- •Harm reduction agencies
- Prevention agencies
- School district employees
- •Social service orgs reaching underserved pops (PEH, LGBTQ+, racial/ethnic minorities)
- Younger folks (college students)

#### How to engage?

- •Make decisions democratically as much as possible
- •Fall back on voting when consensus cannot be found among full group
- Define tech advisory committee structure (but allow some flexibility)

### Technical Advisory Committee Suggested Structure

#### - FROM BOTH PRIVATE AND PUBLIC SOURCES

- 1-2 Behavioral health providers (considering mental health and SUD)
- 1-2 SUD treatment providers (MOUD prescribers are a plus)
- 1-2 recovery experts (peer recovery specialists or recovery community organizations)
- 1-2 harm reduction experts

15-20 people

Areas of Expertise

- 1-2 prevention experts, anyone with youth prevention expertise
- At least 2 community representatives:
  - People with lived experience of SUD, people in recovery, affected community members
  - College aged students (younger representation)
- School district representative
- Law enforcement representatives (if not present on voting council)
- AGO or state representative

#### Engagement

Size

- Include TAC in meetings to complete two-year plan. (gaps, needs, generating program ideas)
- Prior to bringing decisions to a vote, try to find consensus among the full group (voters, non-voters, TAC
