

## SECOND AMENDMENT TO THE INCENTIVE PAYMENT AGREEMENT

This Second Amendment to the Incentive Payment Agreement (the “Amendment”) is entered into as of September 20, 2022, by and between the Board of County Commissioners of the County of Arapahoe, State of Colorado (the “County”) and Charter Communications Holding Company, LLC (the “Taxpayer”).

WHEREAS, the County and Taxpayer entered into an Incentive Payment Agreement dated November 15, 2016, for new and expanded business facilities, which was first amended on October 16, 2018 to correct the addressed locations to 6350 and 6360 S. Fiddler's Green Circle, Greenwood Village, Colorado 80111 and at 6399 S. Fiddler's Green Circle, Greenwood Village, Colorado 80111 (the “Agreement”); and

WHEREAS, the Taxpayer desires to extend the Agreement for an additional five (5) years with a one-hundred (100%) percent incentive payment; and

WHEREAS, the Taxpayer has exceeded the predicted metrics for the new and expanded business locations; and

WHEREAS, the County and the Taxpayer desire to amend the Agreement.

**NOW, THEREFORE, IT IS AGREED** by the County and the Taxpayer as follows:

1. Paragraph 7 of the Agreement is hereby amended in its entirety to read as follows:

7. The term of this Agreement shall commence as of the date written above for tax year 2017 collected in 2018, and shall expire ten (10) years later, after the 2026 tax year with taxes collected in 2027.

2. Exhibit B of the Agreement is hereby amended in its entirety and replaced by the revised Exhibit B, which is attached hereto and included herein.

3. Except as specifically amended herein, all provisions of this Agreement shall remain in full force and effect.

4. This Second Amendment shall take effect immediately upon execution by the Parties.
