PURPOSE

OVERVIEW

- Began in 2008 to fill service gaps in the county
- Operational improvements are considered on an annual basis
- Programmatic improvements are considered every few years
- Supported 51 unique nonprofits, distributing more than \$21,421,331.00
- Internal review committee includes representatives from community resources, human services, and commissioners' office.
- Currently, the Aid to Agencies program funds organizations through two mechanisms:
 - Competitive grant program
 - Safety net organizations

SAFETY NET PROGRAM

- Safety net programs expand community reach for human services and community resources programming
- Often only provider for services in the county.
- Organizations do not submit applications for funded programs.
- The safety net organization may, however, apply to the competitive grant program solicitation for a new program
- The safety net organizations are also not static. Grant approval and/or amount can be altered based on Board direction or if the grantee is not meeting certain guidelines.
- Organizations receiving awards over \$100,000 are required to submit quarterly reports

COMPETITIVE GRANT PROGRAM

Organizations are eligible to apply for competitive grant funding if they:

- Are a registered 501(c)3;
- Provide services that align with at least one of the nine program service areas; and
- Serve Arapahoe County residents.
- Applicants can apply for awards up to \$100,000. Arapahoe County uses the Good Grant platform to solicit the following information from applicants
- Annual report due in January following the award year

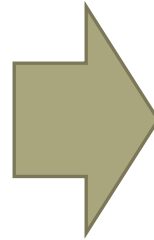

SCORING CRITERIA

Agency Expertise and Background (20%)

Agency Capacity (25%)

Scope of Services (40%)

County Investment (15%)

CRITERIA (CONT.)

Agency Expertise and Background (20%)

- Do the agency's mission, vision, and values align with Arapahoe County's Strategic Plan?
- What work is the agency doing to promote inclusivity and diversity?

Agency Capacity (25%)

- Is the agency able to administer public funds?
- Does the agency have the staffing capacity to provide the services outlined in the grant?

CRITERIA (CONT.)

Scope of Services (40%)

- Do the agency's services align with an identified funding category?
- Does the program extend county-wide and/or provide a geographic-specific service?
- Did the agency specify engagement strategies to reach their intended population?

County Investment (15%)

- Does the funding serve an appropriate/proportionate amount of Arapahoe County residents?
- Is this the only source of funding the organization would receive from Arapahoe County?

2023 FEEDBACK

- Hold an annual application workshop for new and returning applicants
- Provide uniform budget and demographic templates
- Add a representative from A/D Works to the review committee
- Develop penalties for non-compliance with the reporting, communication and health/safety requirements
- Develop a form for scope change requests
- Build an audit process for safety net organizations

PROPOSED TIMELINE

2024 Grant Cycle

June 19 – Application Launches

June 27 – Virtual Pre-Application Meeting with Organizations

July 12 – Virtual Pre-Application Meeting with Organization

August 18 – Application Closes

August – September: Application Review/Scoring

October 10 – Study Session: Review Staff Recommendations

December 6 – Adopt Allocations with 2024 Budget
