The purpose of this study session was to provide an informational summary of CDPHE air quality rules related to oil and gas operations, facility permitting, inspections and air monitoring near oil and gas operations.

CDPHE regulates emissions while COGCC regulates operations and has authority over site locations and equipment.

The CDPHE permits the equipment needed based off the total emissions when inspection occurs.

A plan must be designed 60 days prior to drilling and approved before the start of the process.

A variety of monitoring equipment has been presented.

Quarterly inspections are required in order to examine and identify any leaking equipment that may have an effect on emissions.

The governor as well as local government can all have a stance on the requirements for emissions.
