1:00 PM *Tempe Roundabout Full Closure Request

Tempe Detour Plan

The purpose of this study session was to request the Board of County Commissioners (BOCC) approve a full roadway segment closure for the duration of completion of the Tempe Street Roundabout located between Progress Avenue and Pennwood Avenue (approximately 0.2 miles). The full closure of South Tempe Street during construction of the project would be for 74 calendar days (from May 28th through August 9th). The Public Works and Development Director authority to closure roadways is for a maximum of 20 days. BOCC approval is required for closures of a longer term.

The purpose of the roundabout was presented. The public identified this area as an area of concern due to its lack of stop control.

Concerns with the closure of the roadway were discussed. Time of construction would need to be during non-school dates.

The purpose of this study session was to present an informational update for the Board of County Commissioners (BOCC) on the planned acquisition of portions of the High Line Canal. No BOCC action is requested at this time.

Staff provided a current update with the acquisition of the High Line Canal. Surrounding counties, including Adams County, are considering maintaining their potion of the canal.

A Memorandum of Understanding (MOU) and other agreements need to be completed before the purchase can be finished.

Denver Water and Public Work & Development are working on the accuracy of the High Line Canal Corridor.

Commissioners asked about the authority over the canal and conservation authority.

The purpose of this study session was to request the Board of County Commissioners to authorize the Arapahoe County Sheriff, pursuant to Reso. No. 23-038, to sign the Intergovernmental Agreement for Law Enforcement Services with the Town of Bennett, CO.

Background of the request was presented by the Sheriff. The City of Bennett is wanting to have continuity of law enforcement in the city that is split between Adams and Arapahoe county.

Different resources that will need to be provided were listed such as FTEs and vehicles.

Mayor of Bennett discussed difficulties with contracts amongst different agencies. He was thankful for the consideration from Arapahoe County.

Staff discussed the need of services and the relationship with Bennet and the Arapahoe County Sheriff's Office. Judicial discussions have been ongoing regarding the jurisdiction between the two counties.

Commissioner asked a question regarding School Resource Officers (SROs) and the impact in Bennett.

Commissioner asked questions about the transition date and requested funding.
