A brief staffing composition and funding structure of the Veteran Service Office (VSO) was discussed.

Veteran statistics in Arapahoe County were presented.

Veteran resources and opportunities to increase the VSO scope of services were discussed.

Commissioner Holen expressed gratitude for the work that the VSO has provided, and expressed interest in working with the VSO, along with Commissioner Baker.

Information on supporting VSOs in other counties was presented.

Commissioner Sharpe expressed thanks for the VSOs hard work.

Commissioner Sharpe inquired if there was anticipation on developing programs with other counties based on a percentage of veterans in each county.

Commissioner Baker agreed with an initiative to partner with other surrounding counties.

Commissioner Holen commented on the strategies to increase the scope of VSO services and outreach.

Commissioner Warren-Gully inquired if the VSO was in contact with homelessness programs. Staff indicated that they would refer veterans to organizations that help with housing issues.

All commissioners expressed support for the program. Commissioner Baker reminded staff to be mindful of budget constraints.

Application for Federal Assistance SF-424 COSSAP Grant

The purpose of this study session was to discuss the Arapahoe County Sheriff's Office's interest in applying for the COSSAP grant offered through the Bureau of Justice Assistance (BJA). The Arapahoe County Sheriff's Office is requesting that the Board of County Commissioners authorize the Arapahoe County Sheriff's Office to accept funds from the COSSAP.

Jared Rowlison explained the purposed of the COSSAP program and grant.

The request to fund 2 FTEs for 3 years for custody discharge planning was discussed. Needed support for discharged people was discussed.

Commissioner Jackson expressed support for the application.

Commissioner Warren-Gully asked for clarification on the job duties of the FTEs to be added.

Commissioner Sharpe inquired about the financial sustainability of the grant as the opportunity is only 3 years.

Commissioner Jackson questioned who and how many people this program would benefit.

Commissioner Sharpe mentioned that it would be beneficial for the commissioners to have an update with the Sherriff's office on successes and opportunities.

The Board agreed with the request as presented.

# 2:45 PM \*Open Space Reauthorization Update Shannon Carter, Director, Open Spaces and Intergovernmental Relations

The purpose of this study session was to discuss the preliminary results of open space sales and use tax and changes to the resolution behind it.

Proposed ballot language was reviewed.

Staff recommended that the current percentages and categories remain the same.

Commissioner Sharpe discussed spending with discretion.

Commissioner Jackson inquired how funding would be distributed to different areas in Arapahoe County.

Commissioner Sharpe urged to keep some parameters on what funds can be spent on.

There was discussion regarding "landlocked" cities that do not have open space to acquire.

Commissioner Jackson inquired about next steps.
