The purpose of this study session was to request \$200,000 in Open Space Acquisition and Development funding to support the purchase of a conservation easement on the 1,764- acre Lindsay Ranch in eastern Arapahoe and Elbert Counties.

Maggie Hanna, Colorado Cattlemen's Agricultural Land Trust, presented information about the proposed easement, funding, rights and timeline.

The purpose of this study session is to consider requests for American Rescue Plan Act (ARPA) funding associated with the education, physical health and business support programmatic areas.

A PowerPoint presentation was reviewed, a copy of which has been retained for the record.

County investments to date were reviewed.

Funding requests for education were discussed.

Commissioner Sharpe talked about the importance of focusing on urgent needs.

Staff pointed out that these are one time funds and that is why infrastructure is a focus.

Commissioner Sharpe suggested that Arapahoe Community College expand their program so they can get more nursing students.

The Board agreed to tentatively support the request from ACC.

The request from the Community College of Aurora was explained.

There was discussion regarding how to connect businesses with job seekers.

The Board agreed to tentatively support the request from CCA.

The K12 grant program, to address mental health challenges, was explained.

The Board directed staff to proceed with developing a grant program for consideration, ensuring that the school districts would use this funding for mental health.

Commissioner Warren-Gully suggested basing the funding on a formula instead of a grant and utilizing private providers who are experienced in working with kids.

Funding for Tri-County Health Department was discussed. The Board asked for more information on specific concepts.

The Board agreed with the funding for Stride West Side Dental Clinic.
