#### **Purpose and Request:**

The purpose of this public hearing is to provide all interested persons and citizens an opportunity to be heard concerning the 2022 Recommended Budget for Arapahoe County, the Arapahoe Law Enforcement Authority, the Arapahoe County Recreation District, and the Arapahoe County Water and Wastewater Public Improvement District. The adoption of the 2022 budget will occur on December 14, 2021.

**Background and Discussion:** The 2022 Recommended Budget was submitted to the Board of County Commissioners on October 12, 2021 and contained the budget recommendations of the Executive Budget

Committee. The Executive Budget Committee (EBC) presented these budget recommendations to the Board of County Commissioners during a study session on October 18, 2021. The recommended budget contains projected revenues and expenditures for fiscal year 2022, is in conformance with Colorado law including the Taxpayer's Bill of Rights (TABOR) and other legal revenue and spending restrictions, and the General Fund operating budget is structurally balanced.
