Approval of Litigation Settlement Agreement - Cherry Creek Water & Sanitation District v. Board of County Commissioners of the County of Arapahoe, *et al*

Purpose and Request:

Adoption of resolution authorizing the Chair of the Board of County Commissioners to sign a settlement agreement that has been negotiated in the litigation of v. Board of County Commissioners of the County of Arapahoe, *et al.*, 21CV030385 (Arapahoe County District Court), a review of which was previously provided to the Board in executive session.
