### **Purpose and Request:**

The purpose of this report is to request the Board accept the conveyance of drainage related easements including one drainage easement and one access to drainage easement for recordation by separate document and to adopt a resolution authorizing Bryan Weimer, Director, Department of Public Works and Development to execute the specific easements on behalf of the Board.

Staff has reviewed the easements and has determined that they meet the County's requirements. Staff recommends that the two easements, granted by <u>DC, LLC</u>, be accepted by the Board.

- 2. Authorize Bryan Weimer, Director, Department of Public Works and Development to execute the specific easements on behalf of the Board.

**Background and Discussion:** The easements are located within a Lot 2, Block 1, Dove Valley Business Park Subdivision Filing No. 26, County of Arapahoe, State of Colorado, and is related to the development known as Paonia Building Development (hereinafter referred to as "Plan").

There is one major drainageway in the area, <u>Lone Tree Creek</u>. This development seeks to discharge approved quantities and flows of clean stormwater into the County's storm drainage collector facility, the <u>regional water</u> <u>quality facility, L2</u>. The Owner of the site requests that the attached easements be conveyed to the County prior to the Plan being approved by the Engineering Services Division.
